

LEGAL TERMS AND CONDITIONS OF THE PROMOTION “Forocoches”

1.- Identification of the organizing company

The company Bitcoinforme S.L. (hereinafter referred to as Bit2Me), with registered address at C/ Germán Bernacer, 69, 03203, Elche, Alicante, Spain, and Tax ID Number: B54835301, has organized the promotion called "Commission-Free Purchases" (hereinafter referred to as the promotion), which will be carried out in accordance with the provisions set forth in these Terms and Conditions.

2.- Objective

The purpose of this promotion is to refund the commissions applied to purchases, sales, and cryptocurrency swaps made on the Bit2Me platform (accessible at <https://bit2me.com> and through the "Bit2Me" app on Android and iOS) for new individual customers who access through the promotion's links during its validity period, as well as registered users who have not made any purchases.

Specifically, individuals who register through the link provided for this purpose (<https://bit2me.com/es/join?prm=FC200S>) from the forocoches.com website and have not made a first purchase, even if they have been previously verified, are eligible.

The maximum cashback amount eligible for refund per user will be €200.

Additionally, an invitation to the online forum of Forocoches will be provided as a gift to users who meet the conditions described in Clause 4.

3.- Participation Period

The participation period for the promotion will be from Wednesday, May 24th, until Thursday, June 1st (both dates included), through the Bit2Me platform (accessible at <https://bit2me.com> and through the "Bit2Me" app on Android and iOS).

4.- Reglas y condiciones para participar

All individuals of legal age residing in any country supported by the Bit2Me platform, which can be found at the following link: <https://bit2me.com/en-el-mundo>, may participate in the promotion for a refund of up to €200 of previously paid commissions, provided they meet the following requirements:

- Register your phone number through the landing page provided for Forocoques users at <https://bit2me.com/es/join?prm=FC200S>.
- Complete the registration and verification process. Please note that verification may take several days and is subject to compliance with applicable laws and the platform's terms and conditions.
- Have not performed any previous transactions on our platform.
- To qualify for the commission refund, purchases, sales, or cryptocurrency swaps must be made on the Bit2Me Wallet platform (accessible at <https://bit2me.com> and through the "Bit2Me" app on Android and iOS) within 30 days after registering through the promotion link.

The promotion does not apply to Bit2Me Pro and Bit2Me Earn services. The refund of commissions or fees applied to transactions will be provided in the form of cashback, up to a maximum of €200.

- To receive the invitation to Forocoques, the user must make a first purchase of €100 or more.

Employees of Bit2Me and profiles that have manipulated their participation are not eligible to participate.

Bit2Me reserves the right to make changes to the promotion during its course if any circumstances arise that prevent its successful completion or to improve its progress.

5.- Cashback Refund

All participants who meet the requirements stated in Clause 4 will receive a 100% cashback refund on the commissions or fees applied during the first month of activity in the user's account, starting from the registration made through the provided link, up to a maximum of €200. The Bit2Me Pro and Bit2Me Earn services are excluded from the promotion.

The discount will be applied to the total fees applied to all purchases, sales, and cryptocurrency swaps made within 30 days following registration on the landing page. The cashback refund period will begin on May 24, 2023. Please note that the refund may take several days to process. Participants will receive the cashback in their euro wallet.

6.- Sending Forocoches Invitations

Participants who register on the landing page <https://bit2me.com/es/join?prm=FC200S> and make a first purchase exceeding €100 will receive an invitation to access and comment on the Forocoches.com forum, which they can use individually or transfer to another person.

These invitations will be sent by email to the same email address used by the user to open the account within 7 working days following the first purchase.

7.- Fiscal Obligations

In accordance with the provisions of the legislation regarding Value Added Tax (VAT) and Royal Decree 1619/2012, approving the Billing Regulation, Bit2Me will issue the corresponding invoice for the full amount of fees or commissions applied to each transaction carried out on the platform by those customers (individuals) who meet the requirements established in clause 4 of these legal terms during the promotion's validity period.

Upon refunding the amount of discounts generated on transactions made on the platform during the promotion's validity period to the eligible customers (individuals), Bit2Me will issue a corrective invoice including the amount of the discount effectively disbursed.

In any case, the customer (individual) benefiting from the discounts applied during the promotion's validity period will be solely responsible for complying with their tax obligations regarding invoicing and value-added tax.

8.- Protection of Personal Data

In compliance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (hereinafter GDPR), Organic Law 3/2018 of 5 December on the Protection of Personal Data and guarantee of digital rights (hereinafter LOPDGDD), and any other applicable data protection regulations, we inform participants that their personal data will be included in a Database owned and managed by BITCOINFORME, S.L., with the purpose and legal basis being the management and participation in the promotion, as well as the maintenance of commercial relationships by electronic means based on the legitimate commercial interest of the Bit2Me Group companies (the list of companies can be consulted at www.bit2me.com).

Promotion participants have the right to exercise their rights of access, rectification, erasure, restriction, objection, and data portability by sending an email to rgpd@bit2me.com. Once the purpose of processing has been fulfilled or the deletion of their data has been requested, the data will be blocked and made available to the Administration, Courts, and Tribunals, for the prescription periods of the legal actions corresponding to the treatments carried out in defense of our interests.

The personal data marked with an asterisk on the promotion's registration form are essential for the stated purpose, and the absence of such data would imply the impossibility of registering and validating as a participant.

The participant guarantees that they are the owner of the provided personal data and that the data is authentic. The participant will be responsible for the consequences of providing false data.

Participants in the promotion are also informed of their right to withdraw their consent for commercial purposes regarding the processing of data by the Bit2Me Group, and they have the right to file a complaint with the Spanish Data Protection Agency at <https://www.aepd.es/es>.

9.- Penalties in case of fraudulent use

Bit2Me will consider as fraud any apparently abusive and/or malicious behavior. Likewise, abuse or fraud shall be deemed to occur, by way of example but not limited to, when a participant identifies themselves using a false identity or the identities of third parties without their consent.

Bit2Me does not accept responsibility for any inappropriate or offensive content that users, at their own risk, may upload on the media used for the promotion's development.

Bit2Me is not responsible if any user/customer does not pass the process to have their Bit2Me account verified or if, due to a possible high demand for the Bit2Me account verification process, it cannot be completed before the end date of this promotion.

The identification of any of these practices will result in automatic disqualification and a prohibition from participating in the promotion.

Bit2Me reserves the right to take legal action against individuals who engage in any act that can be considered as manipulation or falsification of the campaign.

9.- Responsibility

Bit2Me reserves the right to make changes or cancel the promotion during its course, in the event of any circumstances that may prevent its successful completion or to enhance its progress.

Bit2Me shall not be liable for any damages or losses that may result from the temporary unavailability or discontinuity of the campaign's operation, the frustration of the utility that users may have attributed to it, or access to different pages and submission of participation responses through the Internet. Bit2Me shall also be exempt from the acts or omissions of participants that hinder their proper participation in the promotion's development.

10.- Acceptance of the Legal Terms

Participation in the promotion implies acceptance of these legal terms. Any expression of non-acceptance of all or part of these present legal terms and conditions implies the exclusion of the participant, and as a result, Bit2Me shall be released from fulfilling any obligations towards said participant.
